PUBLIC SECTOR BUDGET EXECUTION¹ (released 30-03-2016)

Up to February, the State deficit amounted to 1.17% of GDP, slightly below the deficit registered in the same period of 2015 (1.18%). Excluding interest payments, the primary deficit amounted to 0.76% of GDP.

Up to the January, the consolidated budget outturn of the General Government, excluding Local Administrations, was a deficit of 0.62%, against 0.56% recorded in January 2015. Breakdown by subsectors:

• The **Central Government** registered a **deficit of 0.60% of GDP in January**, 0.06 p.p. of GDP less than in January 2015.

• The budget outturn of the **Regional Governments** was a **deficit of 0.11% of GDP**, against a deficit of 0.06% registered in the same month last year.

• The Social Security System recorded a surplus of 0.10% of GPD in the first month of the year, against a surplus of 0.17% of GDP recorded in January 2015.

1. State (February 2016)²

- The latest data of the State budget execution corresponds to February, when the State accumulated a deficit of €13.2 billion. In terms of GDP, the State deficit amounted to 1.17%, against 1.18% recorded in February last year.
- In February, interest payments registered a decrease of 3.1% year–on-year. Net of interest payments, the primary deficit amounted to €8.5 billion (0.76% of GDP).
- Revenues totalled €20.6 billion up to February, registering a decrease of 9.7% year-onyear. Expenditures amounted to €33.8 billion, with a decrease of 5.0% year-on-year.

2. <u>Consolidated budget balance of the Central Government, Autonomous Communities</u> <u>and Social Security (January 2015)</u>³

- The consolidated budget outturn of the General Government, excluding Local Administrations, was a deficit of €6.9 billion up to January, equal to 0.62% of GDP (against 0.56% in January 2015).
- Revenues totalled €24.9 billion, with a decrease of 3.5% in the first month of the year, while expenditures amounted to €31.8 billion, 0.1% less than the previous year.
- Breakdown by subsectors:

2.1 <u>Central Government⁴</u>

- The latest budget outturn information for the Central Government, which comprises the State and its Public Entities, is referred to January. In addition, State's data execution corresponding to February is also published (explained above).
- In the first month of the year, the deficit of the Central Administration was 0.60% of GDP, decreasing by 6% year-on-year. In million euros, the deficit of the Central Administration totalling €6.8 billion, against €7.2 billion registered in January 2015. The deficit decrease in the Central Administration is due to the budget outturn of the State Public Entities, as mentioned below:
 - ✓ The State reduced its deficit by 0.1% year-on-year compared to January 2015.
 - ✓ Public Entities recorded a deficit of €0.3 billion, against a deficit €0.7 billion registered in the same month last year.
- Revenues of the Central Government amounted to €10billion, while expenditures recorded €16.8 billion.

2.2 Regional Governments (Autonomous Communities)⁵

- The Autonomous Communities registered an overall deficit of €1.3 billion up to January, against €0.7 billion last year. In terms of GDP, the overall regional deficit is equal to 0.11% of GDP, 0.05 p.p. of GDP more than in January 2015. Advance payments from the Regional funding system were €0.2 billion this year, against €0.6 billion advanced in January 2015.
- At regional level, revenues amounted to €10.7 billion, while expenditures recorded €11.9 billion.

2.3 Social Security System⁶

- The latest update for the Social Security corresponds to January, when the budget outturn • was a surplus of 0.10% of GDP, 0.07 p.p. less than in the same month of 2015.
- Revenues totalled €12.8 billion while expenditures amounted to €11.7 billion. ٠
